#### **CHILD FIND**

Child Find is an ongoing process of locating, identifying, and evaluating children ages birth through 26, who may have developmental delays or disabilities, who are in need of special education and related services. Children identified with developmental delays or a specific disability are entitled to a free, appropriate public education designed to meet his/her needs.

Hartland Consolidated Schools (HCS), in collaboration with Livingston Educational Service Agency, engages in activities and assessments to identify children who may be suspected of having a developmental delay or disability. This includes students enrolled in private schools, who are home-schooled, mobile, migrant, or homeless.

Referrals for intervention can be made by anyone concerned with a child's educational performance including a parent, child's teacher, community agency, or school official.
